Why Join Now?

Many child and youth-focused donors* increasingly recognize the importance of "shifting power" to young people, decolonizing their strategies, and transforming top-down adult-centric grantmaking. Too often, these intentions are impeded by a lack of understanding of how to do this well, by fears of causing harm or of losing power.

At the same time, justice and decolonization-focused participatory grantmaking (PGM) funds such as *CRIF*, are increasingly documenting their work, but their learnings are not being applied widely. Young people, like *We Trust You(th)*, are self-organizing for donor systems change, but currently lack the collective power to foster accountability.

Who are we?

CRIF а donor learning community and grantmaking fund leading a collective challenge to reinvigorate and transform the global children's rights field by building power with children and youth activists and their allies., We innovation cultivate and collaboration to dismantle the root causes of children's vulnerability and strengthen the root drivers of their well-being.

We Trust You(th) is an initiative that is co-led by five vouth-led organizations from around the world. Together with other partners, they are here to challenge and support youth-focused donors and non-governmental organizations (NGOs) to partner and fund young people more intentionally and equitably. They are driven by the need to end systemic inequities that currently thrive within relationships between youth-led organizations and youth-focused donors and NGOs.

*Note: there are a wide variety of focuses under "child and youth focused donors" differing in age range (i.e., 10-14, 10-24, 19-30), thematic focus (rights, gender justice, education, child protection, etc.), approach (advocacy and activism, movement building, systems change, etc.), and across a variety of geographies. All are welcome if the core values of meaningful youth participation are applicable.

What will we do together

We'll utilize these four interdependent components to guide our work together.

1. LEARN in Community in Real Time.

The Learning Institute will kick off in February 2024, with a three-day in-person training institute in Accra, Ghana that will teach foundational principles critical to strategy-building and grantmaking with youth. In 2024, you will participate in a four-part virtual series that will share what we learn as we learn it directly from the process of strategizing and grantmaking with youth.

2. FUND While You Learn - Move Money Now.

Young people will design a strategy that we will follow and learn from. By pooling \$1M in resources and funding a participatory process together, you will move money to child and youth activists through CRIF's signature youth-directed participatory strategy and grantmaking process.

3. Develop an Actionable PLAN.

You will have the opportunity to apply this learning by developing an incremental plan to improve your own systems. This plan will be tailored to the needs of each organization and will be on a timeline that challenges you, but is also realistic.

4. Be ACCOUNTABLE.

Concurrently, We Trust You(th) will launch a new, youth-defined accountability process to measure the philanthropic sector's progress toward meaningful youth engagement. This holistic accountability standard will prioritize equitable and fair partnerships with young people globally and across multiple thematic areas.

And why are we doing it this way?

The four components of What's Possible are interdependent.

Too often donors only do one or two components, putting them at risk of being extractive or only learning and not taking action, and ultimately stalling progress. With **What's Possible**, your investment (see details below) will cover all four components (learn, fund, plan, accountability) enabling us to collectively demonstrate how it IS possible to collaborate with young people to move resources to their priorities.

Here's a breakdown of the financial contribution needed to join the cohort and learn experientially:

PLAN Pathway Planning	Through guided exercises, you will plan your organization's pathway to more participatory, youth-centered and decolonized grantmaking strategies.		
ACCOUNTABILITY Youth-led Accountability	A proportion of all funds will go towards building a youth-led accountability system for long term progress.		

Additional Anticipated Costs:

You will be responsible for any travel and accommodation costs associated with attending the in-person learning institute, as well as a registration fee. We recommend that 2-4 members of your organization attend together.
